



CAP 2010 PARENT/PARTICIPANT CONTRACT

As a participant in the CAREER ART PATH 2010 program, presented by the Doña Ana Arts Council (DAAC), I agree to the following:

_____ will be a PARTICIPANT in the CAREER ART PATH (CAP) program on June 7-11 and June 14-18, 2010, 8:30 a.m. to 2:00 p.m. daily. Students will show their work in a student exhibition which will be held in the Rio Grande Theatre galleries at the Downtown Mall in July. CAP I will be based in Lynn Middle School. CAP II will be based in Preston Contemporary Art Center.

1. Participant and his/her parent(s)/guardian(s) will arrange to bring participant to base location each day of the program promptly at 8:30 a.m. and to pick him/her up promptly at 2:00 p.m., unless informed otherwise. Student understands that he/she and his/her parents are responsible for arranging transportation to the program in the mornings and from the program in the afternoons. There will be no supervision of children before or after class.
2. Participant agrees to cooperate with and obey the program coordinator and program facilitators while attending the program activities. Discipline problems will not be tolerated. The first occurrence will receive a verbal warning; the second offense, the parents will be called; upon the third offense, parents will be notified that participant is terminated from the program and no refund of fees will be given.
3. Casual, comfortable clothing is appropriate. Students should bring an old shirt to wear during art workshops.
4. Participant must be prepared each day with a sack lunch and a drink.
5. There will be NO smoking and NO use of drugs, alcohol, or any other illegal substance.
6. **NO use of iPods or Cell Phones.** Do not even bring them with you.
7. Participant must attend classes every day unless he/she notifies the program coordinator or program facilitators prior to any absence.
8. Participant agrees to allow his/her CAP art projects to be available for display at the exhibition in July 2010.
9. Participant agrees to allow his/her CAP art projects to be entered into a jury process to determine works which will be exhibited during the month of July at the Rio Grande Theatre Galleries. The jury process will take place on June 18.
10. There will be no refunds of the \$75 registration fee after May 21, 2010.

The Doña Ana Arts Council, as the program presenter, agrees to:

1. Provide a ten-day program that will include a field trip, guest artists, and art activities that will enhance the student's knowledge of, and abilities in a variety of career art paths available to an artist.
2. Provide all supplies and materials to allow student to complete art projects.
3. Provide transportation and food for the field trips to be scheduled unless otherwise arranged.
4. Provide artist reception for opening day of exhibition during Ramble on July 2nd.
5. Provide each student with a tee shirt and CAP certificate of participation.
